### MATTERS OF INTEREST TO COUNCILMEMBERS/FUTURE AGENDA ITEMS

Councilmember Ucovich stated he would like to place on the agenda an evaluation of the downtown park, how it met the goals that we established, and what we might need to approve.

Councilmember Liss stated the following:

- the Penryn Orchard is the third project they have had in the County limits next to our borders
- the County cannot pay Loomis unless we have an agreement with them so this needs to be put on the Council Agenda
- Placer Sustain has proposed a sustainable economic development round table to work with Placer Economic Development Board to develop sustainable economic development goals and Loomis will be a stakeholder and in the Council priorities we agreed to consider what was adopted by the County
- he would like to have staff make an effort to move forward with the grand opening of Sierra College Boulevard (from Granite Drive to Taylor Road)
- Sedcore has a grant to pursue broad band in the rural areas and he would like on a future agenda, a presentation on what services they can provide and how we can get broad band service affordable to our rural areas

- at the last meeting he was pleased to find that the Town was in such good financial shape
- he suggested negotiating with Del Oro and working to get the pool and the sports arena moving, that would contribute to the well being of our Town

## PUBLIC HEARING

10. **2012 Proposed Capital Improvement Program (CIP)** (Continued from June 12, 2012)  
Discuss the 5 year Capital Improvement Program that is divided into two sections, the Transportation Improvement Projects and the Parks, Recreation and Open Space Improvement Projects.  
**Recommended action:** Adopt resolution approving the Capital Improvement Program covering 2012 through 2017  
**Public comment:**

No public comment.

Councilmember Liss stated the following:

- he asked if the Priory funding could be included in the tree mitigation funding
- suggested adding under 2012/2013, item 3, the additional crosswalks on Taylor Road between Shawn Way and Walnut (design and implementation)
- on page 2 he would like to add the Community Facilities Development Fees, \$705,000, as another column
- under passive park funds, consider the use of that for purchase of right of way between Sierra College Boulevard and Heritage Park (for trails in 2013)

Councilmember Scherer stated the following:

- under Scheduled Transportation Improvements 2012/ 2013, add a #6, design trail from Sierra College Boulevard to Heritage Park and use General Fund Transportation money for \$50,000
- the design of "safe route to school" from King Road to Del Oro will be done at staff level
- he would like to put \$10,000 in for the stage in Blue Anchor Park and reduce the cost for the Blue Anchor Multi-Use Plaza construction to \$125,000, the restroom construction to \$75,000 and the water feature construction to \$50,000 under Park Development

Councilmember Ucovich stated the following:

- on the first page (the design the trail) the land should be bought first or you are basically wasting you money
- he would like to move the 2016/2017 Webb Street overlay forward
- he is not in favor of NEV Transportation Plan Preparation, item 5 under 2012/2013

Brian Frাগiao, Town Engineer/Public Works Director, clarified the following:

- he will put \$50,000 in 2013/2014 transportation for trails design and research and under open space for the same fiscal year have property/easement purchases for \$92,000
- he suggested adding to 2012/2013 item 2, "King Road and Swetzer Road Signalization" an alternative bid to do the Webb Street overlay

Councilmember Morillas is not in favor of the NEV Transportation Plan Preparation and suggested moving it to another year until we know what the community wants.

Following further discussion on the matter a motion was made to adopt Resolution 12-20, approving the Capital Improvement Program covering 2012 through 2017 with the following amendments:

- add a column with a community facility development fee of \$705,000
  - add under Parks, Recreation and Open Space Improvements scheduled improvements for 2012/2013 , #7, the Priory mitigation tree planting
  - add to 2012/2013 item #6, Sucker Ravine Trail from Sierra College to Heritage Park design to establish a trail system along Sucker Ravine (between \$50,000 to \$100,000)
  - also, adding a #7, a sidewalk evaluation from Sunrise Loomis Subdivision to Del Oro High School for sidewalk replacement, installation or modification ("safe routes to school")
  - move from 2016/2017 #3, the Webb Street overlay and add to 2012/2013 #2, King Road and Swetzer Road Signalization
  - change the amounts for the Blue Anchor Park the restroom construction to \$75,000, the water feature construction to \$50,000, the Multi-Use Plaza construction to \$125,000, and add \$10,000 for the stage re-build
  - add in the crosswalks for Shaun Way to Oak Avenue with flashers for a cost of \$20,000 to \$50,000
  - add landscaping to 2014/2015 #4, Taylor Road westbound dual left turn lanes onto Sierra College Boulevard
  - add under the Parks, Recreation and Open Space Improvements scheduled improvements for 2013/2014, #3, Sucker Ravine Trail System: work consists of acquiring property or easements to construct the trail system along Sucker Ravine (passive park fund)
  - add under 2016/2017 Improvements item #5, striping the dual left turn lanes on Taylor Road from Sierra College Boulevard to Mobil Home Driveway
  - clarify under "scheduled parks, recreation and open space improvements, item 6, is paid in trees and not cash
- On motion by Councilmember Scherer, seconded by Councilmember Liss and passed by voice vote with Councilmember Ucovich voting no (4/1).
