MATTERS OF INTEREST TO COUNCILMEMBERS/FUTURE AGENDA ITEMS

Councilmember Calvert stated that a few months ago she asked about having a waste receptacle at the park and ride on Horseshoe Bar Road and asked if a trash can could be put over there.

Brian Fragiao, Town Engineer/Public Works Director, pointed out that Caltrans owns that and he will have to talk with them and see if they can put a receptacle over there and maintain it.

Mayor Scherer asked to have that in the Manager's report next month.

Councilmember Ucovich stated the following:

- most of the employees at Raley's wear the shirts that say "a small town is like a big family"
- Raley's received complaints about the change in the new floor plan so they are listening to the customers and changing it back to the way it use to be
- it shows that they are really conscience of the customers in the town

Mayor Scherer stated the following:

- several people have recommended that he replace his Planning Commission appointment, Janet Thew
- she does not fit the need of the community at this stage of our town's development
- our community is in need of individuals who collaborate broadly and build consensus instilling confidence in the decision making process
- he met Pat Taylor when they both were undergoing chemotherapy at Kaiser in Roseville
- Pat Taylor instills confidence in everyone he meets, he can provide much needed healing and guide the future success of Loomis
- he has decided to retire before the end of his elected term in office and asked the Council to appoint Pat Taylor to complete his remaining time in office
- therefore, it is most likely that the October meeting will be his last as Mayor and Councilmember

TOWN REPORT

Pat Brechtal, 5815 Brace Road and President of the Chamber of Commerce, stated the following:

- the Mayor's intentions for the town has been good over the years
- the Chamber has a great staff and location
- they are floundering as a Chamber, he would like suggestions so our Chamber will flourish

Richard Jackson, 4000 Hunters Drive, stated the following:

- the Sierra College Boulevard tree planting is a big mistake, trees won't live there and suggested putting asphalt in
- the potholes on Brace Road have not been taken care of since Homewood Lumber went in

Councilmember Ucovich stated the following:

- he would rather buy banners from a company in California
- he suggested forming a committee of two councilmembers to work with staff in purchasing banners that are made in California

Hazel Hineline, 3443 Barker Road, suggested they use a local business that could order the banners and then silk screen on them.

Jennifer Knisley, 4135 Hunters Drive, suggested considering a "shop local" banner around Thanksgiving or Christmas season.

Brian Baker, 6025 Arcadia Avenue, stated that we need to bring business to the Town and suggested having an area along the freeway where the businesses could hang their signs.

Following further discussion on the matter, the Council consensus was to have Councilmembers Morillas and Ucovich work with staff to pick out and purchase banners.

9. Ordinance Amendment Work Program and Tree Ordinance Update

At the July 9, 2013 Council meeting staff was directed to return with a work plan for updating the Town's Municipal Code and Ordinances.

Recommendation: Review the attached list proposing updates to specific sections of the Town Municipal Code, take public comment, and authorize staff to amend the outdated ordinances.

Public comment:

No public comment.

Councilmember Wheeler stated the following:

- the list before them will keep them busy for a long time
- he is looking to the Town Attorney, Jeff Mitchell, to decide what is the focus that we need to work on first

Councilmember Calvert would like to know which ordinances should go before the Planning Commission first.

Mayor Scherer stated the following:

- suggested having a "purchase local" policy
- we have a Housing Element certification that should be on the list to be done in the next six months
- SACOG is willing to provide any assistance on the Housing Element
- he agrees with the list and direction that staff has recommended

Rick Angelocci, Town Manager, gave a brief update on the Tree Ordinance.

Jeff Mitchell, stated the following:

- there is no legal requirement that a formal study be done
- any fee imposed by the Town needs to be reasonably related to the impact

Mayor Scherer announced that the Planning Commission is having a workshop tomorrow night at 6:30 p.m. on the Tree Ordinance and he would like to see it brought to the Council agenda in October.

10. Webcasting Town Council Meetings

Per Council direction, staff has researched the feasibility and cost of having the Council meetings broadcast over the internet via webcast.

Recommendation: Discuss whether Council wishes to webcast their meetings over the internet and direct staff accordingly.

Public comment:

Councilmember Calvert stated that one of the teachers from the video class at Del Oro is interested in broadcasting our meetings.

Councilmember Wheeler stated the following:

- he would rather see paving on a road then spending town money on this
- if Del Oro wants to come in, practice, use their production skills, and make it an educational experience then he is all for that

Pat Brechtal stated the following:

- he agrees with Councilmember Wheeler, he doesn't think many people will watch this
- he suggested making a recorded version for the public
- he can't get WAVE broadcasting where he lives

Richard Jackson stated that he agrees with Councilmember Wheeler, we don't need it.

Jennifer Knisley suggested recording the meeting and putting it on the website for those that can't attend the meetings.

Shaun Graham, 6786 Horseshoe Bar Road, stated the following:

- he agrees with Councilmember Wheeler and Calvert
- he suggested putting the recording online and see how many hits we get and decide after that

Jean Wilson, 4301 Barton Road, stated the following:

- she agrees with Councilmember Wheeler
- it's a good concept but not worth the money
- recording and putting it on the internet or letting Del Oro do it is a good idea

Hazel Hineline, Barker Road, stated that most people will not be interested in watching the meetings and agrees with Councilmember Wheeler.

Councilmember Ucovich pointed out that maybe Loomis doesn't have the interest in watching the meetings at this time, but in other communities that have webcast, people are watching the meetings.

Councilmember Wheeler stated the following;

- this is a lot of money to spend and if there is a demand for it later then that is the time we should look at it
- having a partnership with Del Oro would be great if they want to come here and do a production
- we could take a DVD over to WAVE and they could decide if they want to air it
- there are other possibilities without the Town spending a dime on this
- he doesn't want to spend any money on this

Councilmember Calvert stated that this should be given to Del Oro if they want to do it.

Councilmember Morillas stated she has never been in favor of this but if Del Oro has the capability and would like to do this then that would be fine.

Mayor Scherer stated the following:

- We have a consensus to follow-up with Del Oro to see if they are interested in broadcasting the meetings
- we need to make sure this isn't something that we may be obligated to fund on an on-going basis
